- (a) Completed Nomination Form in PDF format and duly signed by the Nominator and the candidate.
- (b) A brief description of the Nominee of not more than 100 words for the use of the HKIS for marketing and promotion purposes of the QS Awards 2024.
- (c) A written statement by the Nominee describing his/her working experience, and showing his/her vision and innovation, leadership, motivation, value created for Clients, proactive professional learning and contribution to the HKIS, QS profession and the community.
- (d) Nomination written statement by the Nominator in support of the nomination and with not more than 1,000 words to illustrate the relevance and merits of the candidate in meeting the assessment criteria of the Young QS Awards 2024.
- (e) Written consent from the Nominee to disclose the personal particulars to the QS Awards 2024 Organising Committee and the jury panel for the assessment of the eligibility of admission and award.
